4) Officer Reports:

President: At the Nov. 5 DUESD Board meeting, Mark brought up the general proposal on salary (left open) and the proposal for a change in teach hours (to include a 45 min. lunch). There are 2 reps and a 3rd seat to be voted on. Ballots are to be taken by reps to sites for voting on Wed. and Thurs. – due back at the DUESTA office by Thursday afternoon.

A bargaining survey for each site was sent out and to be returned before Thanksgiving Break.

A disciplinary hearing is coming up in Nov. for a person in the DO.

A complaint must be written and signed by the complainant and only then can a teacher be subject to disciplinary action.

Telling the DUESTA Board that cooperation and collaboration is wanted in the bargaining meetings. Dr. Aguilar responded with a letter removing benchmark testing, but leaving the writing proficiencies. We cannot apply strategies when we don't have a coherent understanding of the standards, when we don't have resources, and we don't have assessments. Nov. 7 – DO did not want Pesante to participate in bargaining. DO's representative agreed with DUESTA that this is not the DO's choice. DO changed timelines in contracted bargaining agreement. Going to impasse about money. Where is the money going?

1st VP: Thanks to new reps who went to training.

Princeton / La Vina – have complaint grievances.

Del Vista – teacher on medical leave – HR didn't like the doctor's note, and it took them 6 days to meet. Time off should NOT come from teacher's personal necessity leave.

5 complaints for harassment have not be investigated yet.

Remind teachers to request their DUESTA rep, and it is not insubordination to stop talking until the rep is present.

Mark and Darrell went to the Region 2 conference: be aware of bullying and report it, don't panic about health and welfare benefits

2nd VP: Please e-mail teachers about their rights.

Encourage teachers to get involved in DUESTA meetings and read the e-mails being sent out. Pocket calendars are coming to be sent out.
